## **Re: Foundation Organics Composting Facility: An Environmental Hazard**

Dear Premier,

We, the people of Tanner Ridge Community<sup>1</sup>, Central Saanich, BC are writing to you to ask for your help in solving a serious problem affecting our community consisting of over 1000 households.

The composting facility operated by Foundation Organics at Stanhope Farm (6341 Old East Road, Central Saanich, BC) continues to belch out a revolting stench day after day, putting at risk our health and well- being and our property values.

Capital Regional District (CRD) awarded a license to compost the *restricted organic matter* to this private industrial composting facility located at less than 400m from our residential area. With not enough capital and managing experience to operate such a facility, all the obnoxious "by-products" from this operation are already in the atmosphere, in our houses and our lungs.

## This is a health and environmental disaster for our community and it is seriously affecting our quality of life <sup>3</sup>.

Composting odour emissions beyond the operator's property boundary are the direct responsibility of the CRD. At current levels, these emissions are in violation of CRD's own Bylaw 2736 section 6.1 and CRD policies and procedures call for escalating enforcement action for continuing offences, and ultimately, license cancellation. Noxious odours and other disturbing issues from this facility have been an ongoing problem for residents in this community for more than two years. Despite all the complaints of people living in this neighborhood, to the CRD, the Municipality of Central Saanich and the Vancouver Island Health Authority (VIHA), nothing has improved...on contrary it is getting worse<sup>2</sup>.

We are calling on you and the ministers in your government to take immediate action to either close or relocate the composting facility to a more appropriate location, away from a highly populated residential community.

Our community as well as all the communities on Vancouver Island is a strong contributor to the BC's wealth and prosperity and we believe that we, and our children, are entitled to live a normal and healthy life in our beautiful province.
